Executive Summary

- 30% of families whose children attend Haddenham schools, more than 100 families, live outside Haddenham and are driven into the village; there are no school buses
- 36% of all children (and 18% of those living in Haddenham) are driven all or partway to school
- There was 79% support for a 20 mph limit throughout the village and a further 17% support for a 20 mph speed limit on some roads in Haddenham
- Parents report that vehicles are travelling too fast for conditions on the road
- Parents find it difficult to get their children to school safely, because of the narrowness and condition of the pavements or because there is no pavement at all e.g. Aston Road
- Since lockdown, with many parents working from home, more children have walked or cycled to school
- 59 families in Haddenham have tried cycling and found it too dangerous to continue
- Some Haddenham roads, e.g. Thame Road, Churchway roundabouts and Stanbridge Road, are difficult to cross, either because of the speed of the traffic on straight roads, or because of poor sight lines
- Potholes on roads and pavements make travel difficult for children on bikes and scooters and for their parents with buggies

Overall, parents are concerned that it is difficult and sometimes dangerous to travel on foot, bike and scooter to our schools; therefore some locals drive cars instead.



Introduction

The increase in traffic on village roads, as well as the climate crisis, make it urgent for us to reduce car use in the village, so ultimately we need to know from all members of the village community, what the obstacles are to achieving this. Haddenham Safe Walking & Cycling Group decided to start with parents whose children travel to our village schools.

Angela Matthews and I worked with all three village primary schools. We would like to thank Rebecca Richardson at Haddenham St Mary's, Emma Lister at Haddenham Community Infant School and Andy Leach and his team at Haddenham Community Junior School, together with all the parents who took the time to complete the survey.

In the past, six similar surveys¹ have been carried out by Angela between 2004 and 2017 using only HCJS parents. This was the first ever travel survey for parents at all three Haddenham schools. It took place from Oct 20th to Nov 20th 2020 before the current lockdown but while many parents were working from home. Survey Legend *www.surveylegend.com* was used so that it was easy for parents to reply on their phones; it also made analysis of the replies speedier.

There were exactly 200 responses to the survey. This gives a response rate of over 40%, which is a high response². We included this time topical issues such as a possible village-wide 20mph speed limit and the pop-up cycle lane along Thame Road. We also asked parents for their ideas for improvement in general, unconstrained by the specific questions.

There were ten questions and an analysis of the replies follows. The first nine questions were multiple choice. For the first three and for question 9 parents were asked to tick one option only but for the others they were asked to tick as many options as applied to them. Questions 3 to 9 also allowed space for a text reply to cover other options. Analysis of these text replies is in Appendix 2.

The final question asked parents for comments about reducing car use in travelling to school and/or improvements which the schools or councils could make to help walkers and cyclists. 95 parents took the trouble to add comments (47.5% of respondents). Although some of these were short, there were also some long comments where people felt very strongly about traffic issues in Haddenham. For a full analysis see Appendix 1. Significant comments made by more than one person are included in the main report.

I thank Angela unreservedly for her hard work in the thorough analysis of the results.

- 1. 200 families represent more than 40% of the total at the three village schools.
- 2. Actual percentages living in and outside the village are approx. 70% and 30%, so the sample includes a higher proportion living in the village.
- 3. With the exception of one child who travels by bus and one child brought by transport provided by the LA, all children living outside the village are driven to Haddenham, though not necessarily all the way to school see Q3 for further breakdown.

- 1. We can deduce that the sample represents at least 239 children but cannot be sure of the exact number. All we can say is that those ticking options a, b and c have at least one child at school, while those ticking e and f have at least two children at school in Haddenham.
- 2. One family stated that they had a child at all three village schools.

- 1. The answers to Q3 show how children regularly travel to school. This does not mean that they travel this way every day and travel patterns can vary considerably over the week.
- 2. For children living outside Haddenham, 69% are driven all the way to school, 27% park & stride, 1 (2%) travels by bus and 1 (2%) in transport provided by the LA.
- 3. Corresponding figures for children living in Haddenham are -10% are regularly driven all the way to school, 8% park & stride and 2 children (1%) travel by bus. The rest walk, scoot or cycle and one is brought in a bike trailer.
- 4. Of the 16 people (10%) who live in Haddenham but drive their children all the way to school 10 go on to work and 3 are put off by other issues (2 say walking along Thame Rd feels unsafe and 1 mentions narrow pavements).
- 12% of children living in Haddenham cycle to school. Compared with previous HCJS parent and child surveys this figure is high possibly reflecting lockdown and home-working – see analysis in Table 2, Appendix 1.
- 6. Cycling is usually popular between Easter and October half-term but few children cycle every day for the reasons set out in Q6.

- 1. Questions 3 and 4 ask slightly different questions. Q3 asked people to choose one option only so percentages relate to the number of people replying. Q4 asked people to choose all options applying to their family so the percentages relate to the number of responses.
- 2. Q4 option a includes walk, scoot and park & stride.
- 3. There are inconsistencies in the way people have answered both questions.
- 4. For the 4 people who live in Haddenham but say they live too far from school to walk 2 drive all the way (and parent goes on to work), 1 travels by bus and 1 ticked park & stride. The other person living in Haddenham and travelling by bus skipped Q4.
- 5. The breakdown of text responses for 4i 'other', is shown in Appendix 2. The two main reasons are feel unsafe/Thame Rd feels unsafe/traffic too fast and poor pavements (too narrow, uneven, poor quality).

- 1. Options a, b, e and g show people who cycle to school at least some of the time and represents 23% of responses from people living in Haddenham (excluding double-counting). As explained in the notes to Q3, this is a high percentage.
- 2. 4 people living outside Haddenham do cycle in occasionally and another 3 have tried it.
- 3. The main reason given for not cycling is that it is too dangerous (25% responses) and a further 15% of responses indicated people would start cycling if there were dedicated cycle lanes see also Q7.
- 4. The breakdown of text responses for 6j 'other', is shown in Appendix 2. The two main reasons are families live close to the school/children prefer to walk and safety fears (unsafe, dangerous roads/too much traffic or traffic too fast).

- 1. 79% of replies are from Haddenham residents. This is not exactly the same group of people in favour of 20 mph throughout the village and it is purely co-incidental that the percentages are the same.
- 2. A surprisingly large percentage of parents living outside Haddenham support 20 mph throughout the village

Q10 Please comment about reducing car use for travelling to school and/or improvements which the schools or councils could make to help walkers and cyclists

95 people wrote comments each reflecting their own particular issues with travel to school and each comment was quite different from the others. All comments were read (several times) very carefully to get a feel for the main issues that concern parents. In some cases the comments amplified answers given in earlier sections, particularly in support of 20 mph throughout the village (12 repetitions). Other comments were quite individual.

Comments also varied considerably in length from 5 words to 179 words. It was not possible to word count all of them, so the comment length in centimetres was used as a proxy – see Table 3 in Appendix 1. 63% were quite short, 5% very long and 32% intermediate. The length of the comments did not necessarily reflect the number of issues raised. For example, one of the shortest comments (8 words) mentioned three different issues, whereas the longest (179 words) covered a range of issues on one subject, problems getting from the new development next to the Garden Centre to St Mary's School.

Most comments covered more than one topic and altogether 235 different issues were identified with broad themes emerging. This enabled an analysis to be carried out – see Table 1 in Appendix 1. This approach was used in the six previous Junior School surveys, although this time the range of issues was expanded to cover the whole village.

The overall impression is that a lot of people would like to walk or cycle but consider the situation in Haddenham does not encourage it and, particularly for cyclists, is quite dangerous, as can be seen from Table 1 in Appendix 1. The issues that stood out were –

- The traffic is too fast and the driving aggressive
- A 20 mph speed limit is needed throughout the village
- There is too much traffic in the village and new developments are causing more e.g. by being too far from schools
- Safer cycle routes and more dedicated cycle lanes are needed
- Cycling on village roads is dangerous and some children cycle on the pavement
- Potholes deter people from cycling
- People will not cycle from outside the village unless safe cycle routes are provided
- Pavements are too narrow or poor quality
- Pavements are needed for Aston Road and Stanbridge Road south of the Garden Centre
- There are many parking issues and some suggestions Church End is particularly bad
- More safe crossing points are needed in the village and 6 parents asked for a School Crossing Patrol at the Woodways/Churchway junction or Church End
- In addition to strong support for 20 mph speed limits in the village, 6 parents said they would like streets around the school (Woodways and Church End) to be closed at school drop-off and pick-up times
- Lockdown and working from home have led to more people walking and cycling to school

• Only 2 people mentioned pollution problems from traffic (one in connection with people sitting in cars with the engines idling) and only one person referred to the climate crisis.

The Parents' Survey was sent out just as the new pop-up cycle lane was installed, with the new advisory 20 mph speed limit from the station to the Junior school. It is worth remembering that both emerged one day with no warning or explanation. In fact one of the comments about the 20 mph speed limit (which the writer supported) was that the signs '... are small and look temporary/like a trial..'!

Parents had very little time to get used to the new arrangements before completing the survey so it is perhaps not surprising that a lot of parents commented about the trial but it should be remembered that these were 'first impressions'. It might be interesting for the Council to ask their opinions when the trial ends.

Two people commented about the trial 20 mph speed limit, both in favour.

Eighteen parents commented about the trial cycle lane. The trial has given people the idea that cycle lanes might be possible, so some people, while not in favour of the current arrangement, actually wanted it improved. One of the main complaints was that cars still pass each other while driving too close to cyclists (close passing).

Seven people made negative comments only, while three people were in favour of the current arrangement and one wanted the cycle lane improved. Three people wanted cycle lanes in both directions, two people suggested other routes and two were ambivalent. It was quite a complex picture.



Conclusions

30% of families whose children attend Haddenham schools, more than 100 families, live outside Haddenham and are driven into the village (Appendix 3). We thus have a problem about how to reduce this influx of vehicles on our roads - school buses?- and about where the cars should park considerately - dedicated car park?- because at the moment the influx and the parking cause problems for other parents in crossing roads and in cycling safely.

Parents are concerned about the speed of traffic and there is wide support among them for a 20 mph speed limit.

Some Haddenham roads e.g. Thame Road, Fort End, Stanbridge Road and the Churchway roundabouts are difficult to cross, either because of the speed of the traffic on straight roads, or because of poor sight lines or parked cars.

Parents find it difficult to get their children to school safely for many reasons but the width and condition of the pavements are currently of particular concern. At school times the pavements are crowded and users are travelling at different speeds; anyone who has pushed a buggy with a 3 year old hanging on the handle or dawdling behind and a schoolchild on a scooter ahead is aware of the enormity of the task on a wide pavement. On our narrow pavements it becomes dangerous, as people are forced to step onto the road.

Potholes on roads and pavements are an additional hazard, particularly when they are full of water and pedestrians get soaked.

A great majority of parents think that cycling on the road for any of their children is too dangerous and the narrowness of the pavements makes cycling on them, even for small children, very difficult. 59 families have tried cycling to school and stopped because of the dangers. They want improvements to the environment to enable safe cycling to school.

Thus it is no surprise that 36% of all children (and 18% of those living in Haddenham) are driven all or partway to school. Furthermore much of the new housing is distant from village schools (especially Aspen Park) and this makes it difficult for families with young children to complete the long journey on foot. The absence of dedicated paths for walking and cycling from these estates to our schools intensifies the problems facing parents.

This survey shows that Haddenham needs urgent help in making the village a safe place for our younger generation, in particular, and for all of us who wish to travel on our feet, in our wheelchairs, on our scooters, our mobility scooters, and on our bikes round our beautiful village.

Five people commented in Q10 that they walked or cycled to school more often because they were working at home (3) or because of the reduced traffic during lockdown (2). This prompted the following analysis showing the combined number of people walking and cycling more since the first lockdown. Questions 4 and 6 (options b) asked if people walked or cycled to school more *since lockdown*. This could cover both working from home and reduced traffic.

Although there are no measures of traffic volumes to enable a comparison to be made between the time of the survey and normal, pre-Covid times, anecdotally the feeling is that reduced traffic has continued since the first lockdown. Despite this many people still complained of high traffic volumes and traffic issues, reflecting more normal times.

APPENDIX 2 - Analysis of text responses to questions 4 to 9

The first three questions in the Parents' Survey were standard questions that have been asked in previous surveys conducted at HCJS to give some basis of comparison. They all required one answer only.

Questions 4 to 8 asked parents to choose all the options which applied to their family and sought to find parents' views on walking and cycling in Haddenham. All of these questions included an option where parents could enter by text a choice that was not included in the list given to them.

Question 9 asked parents if they support the introduction of 20 mph speed limits in Haddenham. They were asked to choose one option only. In addition to the four options listed (which included no support for a 20 mph speed limit on any roads in Haddenham) an option was included for parents to enter other suggestions for roads which might benefit from the introduction of a 20 mph speed limit.

A full analysis of the replies received for questions 4 to 9 is as follows -

Q4 Which of the following statements most nearly represents your views on walking and scooting in Haddenham?

Option: We would like to walk/scoot to school but are put off by other issues – 28 people gave often quite detailed answers, covering more than one point. The main themes were

There were 12 replies, only five listed roads, one was facetious and three were not sure! One commented that the new cycle lane is unsafe (didn't mention it in questions 6 or 7), one said that it was not safe to cycle from Waddesdon to Haddenham and one said they would cycle through the industrial estate if it were safer.

Of the remaining 5 answers which listed roads, 2 people gave Townside, 1 gave Aston Road/Churchway, 1 gave Roberts Road (too many parked cars) and 1 gave Dollicott/Townsend.

Q9 Do you support the introduction of 20 mph speed limits in Haddenham?

Option: We would support a 20 mph speed limit on the following roads

There were 6 responses to this question. One was jokey/facetious (same person as for Q8), one felt 20 mph would not be needed if pavements were safer and wider and one suggested having 20 mph just at school pick up/drop off times. This person has seen signs in other villages which light up to indicate 20 mph at these times.

The other three replies suggested 20 mph in Woodways and at Church End around the schools.

Summary Q 4 to 9

Several themes were repeated in the answers to all these questions and several roads were particularly mentioned as problems. There is quite a feeling that it is unsafe to walk or cycle in the village and the reasons mainly given are the volume and speed of traffic. There is also a strong feeling that pavements are poor – narrow, uneven and in poor condition – which adds to the feelings of lack of safety. Interestingly, parking on pavements did not feature much.
